V. Old Business

Reconstitution -

All documentation has been processed by the City Reconstitution Ordinance passed Committee and the public hearing will be scheduled. SSA 62 will receive a bill for the public notice that was required.

District Lighting -

Discussion was had about the duration of the lighting, with Marcia agreeing that having lights yearround would be preferable. In order to accommodate the program for this year, the commission agreed to a pilot program for the winter, which will be evaluated after the season ends. Al Klairmont made a motion to approve lighting for the winter season, with costs not to exceed \$18,000.

Marcia Jiminez seconded.

Motion passed unanimously.

A follow up with the lighting contractor will take place prior to 10/22.

Al Klairmont provided an update on Imperial Realty's proposed project at 4801 W Peterson. Talks are ongoing with the City to vacate a section of N Caldwell Ave, which provides access to the parking area. The Commission confirmed its support of the project.
