Provide a safe, attractive, friendly and hassle-free experience for pedestrians, cyclists, commuters, shoppers and local workers.

- a. Beautification It was agreed to request a meeting with CDOT to discuss potentially shifting the gateway location further west. The Chamber will arrange the meeting date as soon as possible to help ensure that his project is expedited. The 4801 W. Peterson project has received preliminary approval and will advance through the process.
- b. Finance A copy of the July and August bank statements and tax inflow reports were distributed, along with a copy of the August 31 Chamber reimbursement receipt.

- a. 2018 Budget YTD We are operating within the guidelines of the budget without any major exceptions.
- b. 2019 Budget Public Way Aesthetics In addition to the 3rd community identifier and 2 landscaping installations: summer and winter, ideas included the installation of additional decorative lighting, and painting the light poles on Cicero and replacing their bulbs with LED bulbs. Topic to be revisited in 2019.

VI. New Business

- a. 2018 Winter Landscaping The commission liked the combination of live evergreens, birch logs, dogwood branches and cut evergreen boughs for a variety of color and texture. This will be brought before the commission for a vote at the October meeting.
- b. District Security If individuals are spotted tampering with or stealing foliage, 911 will be called immediately, followed by full police reports.
