## **Shop Sauganash Mission**

# II. Meeting Minutes

- a. Spring/Summer Landscaping: The plant material in the existing 18 sidewalk planters and 16 hanging baskets was installed in late May. The additional 18 planters have been installed with foliage.
- **b.** Edgebrook SSA Advisory Committee Status Due to the impact of the sewer construction on Devon Avenue, the Chamber requested and was granted a one-year deadline extension for the Edgebrook SSA by the Department of Planning and Development. A mailing will be sent to all affected property owners.
- c. The Chicago Sculpture Exhibit installed the sculpture "North Star" by Dan Shaughnessy in front of the Polish National Alliance. It will remain there for one year.
