Shop Sauganash Mission

Mary Lou Quinn/BQS Realty – The loss of Mary Lou Quinn and the pending sale of 6023 N. Cicero creates an office space issue. Imperial Realty has inventoried their available space and will help secure a new location.

Scooters have been parked attached to parking meters on Peterson. If they are present longer than a few days, calls can be made to retrieve them. The scooters must be fastened to something stationary, including bike racks.
